

This was initially filed electronically. The only reasoning I can gather for you not receiving it is a technical issue which none of us have any control over.

I, Jennifer Kowalski, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief and that I expect to be able to provide the same at a hearing held in this matter. Simple Transport LLC is not now engaged in intrastate transportation of property or passengers for compensation in this Commonwealth except as a authorized by the Pennsylvania Public Utility Commission certificate or permit, and will not engage in the transportation for which approval is herein sought, unless and until the transportation is authorized by your Honorable Commission.
