We are writing in accordance with Chief Administrative Law Judge Rainey's Interim Order dated June 2, 2015 setting this Application for resolution conference. We represent MTR Transportation, Inc. (MTR), t/d/b/a K-Cab Co., which was the only Protestant on the date of Judge Rainey's Interim Order. Prior thereto, we made a settlement offer to Applicant on MTR's behalf. Applicant retained Craig A. Doll, Esquire on June 4, 2015.

Paul's Cab Service, Inc. (PCS) filed an untimely Protest on June 9, 2015. It was 36 days late and not served on MTR or us. The Protest deadline expired May 4, 2015. There is no other Protest. Applicant filed a Motion to Strike PCS' Protest as untimely. That Motion is pending.


Applicant and MTR through their respective attorneys conferred on June 16, 2015 and again on June 25, 2015 to discuss the settlement originally proposed by MTR. Applicant's attorney, Mr. Doll, has indicated that MTR's interest probably will be resolved based on MTR's settlement offer, if PCS' untimely Protest is stricken.


