

I am considering your July 30, 2015 offer, which was received on August 1st.



At this point, I have conditions to propose. I can provide an answer to PPL's July 30th offer on or before August 23, 2015.

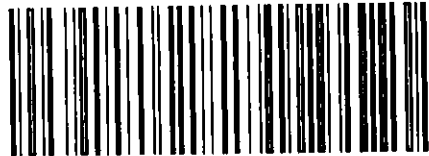
