5. Applicant shall serve the within Order on all interested parties and file a certificate of service.

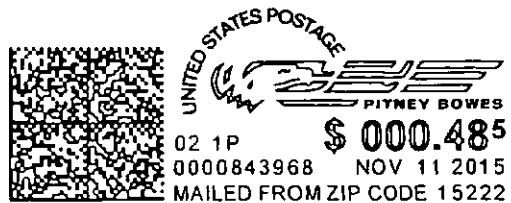
