## APPLICATION FOR ORDER AUTHORIZING THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS OF SOMERSET REGIONAL WATER RESOURCES, LLC TO EMPLOY COUNSEL, NUNC PRO TUNC

The Official Committee of Unsecured Creditors of Somerset Regional Water Resources, LLC (the "Committee") hereby files this Application for Order Authorizing the Official Committee of Unsecured Creditors of Somerset Regional Water Resources, LLC to Employ Counsel, *Nunc Pro Tunc* (the "Application"), respectfully represents the following:

## **JURISDICTION**

1. The Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and

2. Venue of the Debtor's Chapter 11 case is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

#### THE DEBTOR

3. The Debtor, Somerset Regional Water Resources, LLC (the "Debtor"), filed a Voluntary Petition for relief under Chapter 11 of Title 11 of the United States Code, 11 U.S.C. § 101 *et seq.*, (the "Bankruptcy Code") on November 9, 2015 (the "Petition Date") in the United States Bankruptcy Court for the Western District of Pennsylvania at the above-captioned case number (the "Bankruptcy Case").

4. On December 1, 2015, the Office of the United States Trustee appointed the Committee in the Bankruptcy Case. Immediately thereafter, a meeting of the Committee was held.

5. The Committee elected Admar Construction Equipment and Supplies, Michael Tanea, Corporate Credit Manager, as Chair of the Committee.

### **RELIEF REQUESTED**

6. The Committee seeks to engage, subject to Court approval, John M. Steiner, Esquire, and the law firm of Leech Tishman Fuscaldo & Lampl, LLC ("Leech Tishman"), 525 William Penn Place, 28<sup>th</sup> Floor, Pittsburgh, Pennsylvania, to represent the Committee in this Bankruptcy Case pursuant to Section 1103 of the Bankruptcy Code.

5. The Committee has selected John M. Steiner and Leech Tishman because they have extensive experience in commercial bankruptcy matters, including representing creditors' committees in complex Chapter 11 cases. The Committee believes that John M. Steiner and Leech Tishman are well-suited and well-qualified to represent the Committee in this Bankruptcy Case.

6... The professional services to be rendered by John M. Steiner and Leech Tishman are as follows:

- A. Provide the Committee with legal advice with respect to its duties and powers in this Bankruptcy Case;
- B. Assist the Committee in its investigation of the acts, conduct, assets, liabilities, and financial condition of the Debtor, the operation of the Debtor's business, and the desirability of the continuation of such business, and any other matters relevant to the case or to the formulation of a Plan;
- C. Review the Debtor's proposed Plan and Disclosure Statement, to participate in the formulation and/or modification of a Plan and propose a Committee plan, if necessary; and
- D. Perform such other legal services as may be required and in the interest of creditors.

7. It is essential that the Committee employ an attorney for such professional services.

8. Attached hereto as Exhibit "A" is an Affidavit of John M. Steiner and Leech Tishman Fuscaldo & Lampl, LLC pursuant to Rule 2014(a) of the Federal Rules of Bankruptcy Procedure (the "Affidavit").

9. To the best of the Committee's knowledge, John M. Steiner and Leech Tishman are "disinterested" persons, as that term is defined in Section 101(14) of the Bankruptcy Code.

10. To the best of the Committee's knowledge, neither John M. Steiner nor any member, partner, or associate of Leech Tishman holds any connection or adverse interest to the Debtor, its creditors, or any other party in interest, their respective attorneys and/or accountants, the United States Trustee or any person employed in the office of the United States Trustee except as set forth below and in the attached Affidavit:

A. Leech Tishman previously represented Oester Trucking, Inc. ("Oester Trucking"), a creditor, in an adversary proceeding seeking to avoid and recover preferential transfers in an unrelated bankruptcy proceeding. Further, Oester Trucking retained Leech Tishman to represent its interests in this Bankruptcy Case. Leech

Tishman has notified Oester Trucking that it must retain new counsel in this Bankruptcy Case.

- B. Leech Tishman previously represented Somerset Trust Company ("Somerset Trust"), a creditor, on a specific employment matter that is unrelated to this Bankruptcy Case. That matter is closed. Leech Tishman is able to take action, including litigation, against Somerset Trust.
- C. Leech Tishman previously represented First Insurance Funding Corporation ("First Insurance"), a creditor, in a general litigation matter that is unrelated to the Bankruptcy Case and as a creditor in an unrelated bankruptcy case. Both those matters are now closed.
- D. Leech Tishman represents Waste Management, a creditor, in various real estate and environmental matters, none of which are related to this Bankruptcy Case. Leech Tishman does not represent Waste Management's interests relating to its unsecured claim in this Bankruptcy Case.
- E. Finally, Leech Tishman had a prior financial relationship with Norma Hildenbrand, Esquire, who is a staff attorney with the Office of the United States Trustee for the Western District of Pennsylvania. Prior to accepting a position with the Office of the United States Trustee, Ms. Hildenbrand was in private practice as Norma Hildenbrand, Esq. P.C. At the time Ms. Hildenbrand became a staff attorney for the Office of the United States Trustee, there was an agreement with Leech Tishman under which Norma Hildenbrand, Esq. P.C. referred certain matters (other than bankruptcy matters) to Leech Tishman.
- 11. Leech Tishman will undertake this representation at its standard hourly rates, plus

reimbursement of the actual and necessary expenses incurred including, but not limited to, travel, photocopying, telecopying, postage, long distance, and such other charges, which are customarily charged to the Leech Tishman's clients. Leech Tishman's current hourly rates as of January 1, 2015, are as follows:

Partner Time	\$245.00 to \$705.00/hour
Associate Time	\$175.00 to \$490.00/hour
Paralegals and Law Clerks	\$50.00 to \$230.00/hour

12. These hourly rates are subject to periodic adjustments to reflect economic and other conditions usually on January 1<sup>st</sup> of each year. Leech Tishman may make periodic applications for interim compensation.

13. John M. Steiner and Leech Tishman reserve the right amend this Application and to file an amended affidavit under Rule 2014.

WHEREFORE, the Committee respectfully requests that this Court enter an Order, substantially in the form attached hereto, authorizing and approving the Committee's engagement and employment pursuant to 11 U.S.C. § 1103 of John M. Steiner, Esquire, and Leech Tishman Fuscaldo & Lampl, LLC to represent the Committee in this Bankruptcy Case under the terms set forth above, *nunc pro tunc*, as of December 1, 2015, and granting such other and further relief as may be just and proper.
