OPERATING AGREEMENT
OF
PARKER TRUCKING, LLC
(A Pennsylvania Limited Liability Company)

This Operating Agreement ("Agreement") of PARKER TRUCKING, LLC, hereinafter referred to as "Company", effective as of January 1, 2016, has been adopted by and among CHRISTOPHER P. RECITALS

WHEREAS, the Company has been organized as a Pennsylvania Limited Liability Company by the filing of a Certificate of Organization with the Department of State of the Commonwealth of Pennsylvania under and pursuant to the Pennsylvania Limited Liability Company Law of 1994, 15 Pa.C.S.A. §8901, et seq., and any successor statute, as amended from time to time, hereinafter referred to as "Act"; and

WHEREAS, the Members wish to set forth in writing the internal governance and operation procedures of the Company.

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, and intending to be legally bound hereby, the Members agree as follows:

General Definitions

The following capitalized terms shall have the meanings specified in this Section. Other terms are defined in the text of this Agreement, and, throughout this Agreement, those terms shall have the meanings respectively ascribed to them.

"Act" means the Pennsylvania Limited Liability Company Law of 1994, as amended from time to time.

"Agreement" means this Operating Agreement, as amended from time to time.

"Code" means the Internal Revenue Code of 1986, as amended, or any corresponding provision of any succeeding law.

"Company" means "PARKER TRUCKING, LLC", the limited liability company organized in accordance with this Agreement.

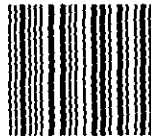
