Dear Ms. Krupka:

I can accept a check to me drawn from the PPL Corporation that is similar to the enclosed copy of PPL's check # 74368 refunding my May 7, 2014 check # 1643 (Exhibit B), which completed payment of all charges on my April 23rd Bill (Exhibit D).

I will not accept a check drawn from the PPL Electric Utilities Corp. account of Ronald L. Hoffman.

I can agree that "all outstanding legal and factual disputes in this proceeding, as to Respondent, PPL Electric, only" have been resolved on one condition: that PPL Electric can agree to provide a copy of the signed fix form with location of the sender, received by PPL on June 17, 2014, within a reasonable period of time after agreement is made. I ask that PPL write this condition into an Agreement I can sign.

This fix form became a material fact when Eshibits 1-3 were introduced into this proceeding by Attorney Graig M. Schultz on September 10, 2015.

There is no record in PPL Exhibit 3 of two faxes from me that were sent from Staples.

My Exhibit H - June 17, 2014 authorization of service in my name - is incomplete. A complete copy of the two letters sent both times on June 17th is enclosed.

The first page is copy of June 17, 2014 signed letter authorizing new service in my name. Copy of June 13th letter to PPL billing in Allentown (Exhibit G) was attached to correct the address and to indicate that service to the owner could not have "ended" before the owner's PPL bill arrived in my mailbox on June 12th.

The Staples receipt is affixed to Confirmation #1, which has

the wrong date and time. but was a little before the time on June 17th receipt (12:57pm). Confirmation #2 was a correction of Confirmation #1 by the manager, who noted the mistake and sent a second fax at 6:30 pm which appears in Confirmation #3,

According to these Confirmations from Staples, PPL Electric received two 2-page faxes frpm me, which authorized new service in my name on June 17, 2014, but failed to note them in its records.

Instead, according to page 4 of PPL Exhibit 3 (copy enclosed), on 06/17/2014, new service in my name was authorized by a fix form that I neither sent nor signed. Both the existence of a fix form and my alleged agreement on this fix form to backdate a new account from June 17th to May 9th were made known to me by reading PPL Exhibit 3, which arrived on September 14, 2015.

Also enclosed is 2-page copy of the unsigned fix form mailed to me by Carole at PPL on May 14, 2014. A foreign load was found on my meter on April 22, 2014. Because both PPL and the owners have a vested interest in signing for the tenant, the tenant's signature is required on a fix form. PPL's fix form lacks my signature.

I will be satisfied with a check to me from PPL Electric for \$418.75 and PPL Electric's written Agreement to provide, within a reasonable time frame, a copy of the signed fix form that was entered into PPL's records on June 17, 2014, along with the fax number - or other location - from which the fix form was delivered.


