


I am withdrawing my 3/17/15 Formal Complaint to the Pennsylvania Public Utility Commission on today's date.

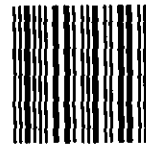
