Enclosed for filing is PECO Energy Company's proposed Act 129 Conservation Service Provider ("CSP") contract with ANB Systems, Inc.¹ ("ANB") for which PECO requests Commission review and approval. PECO procured the contract in accordance with the competitive request for proposals ("RFP") process approved by the Commission on April 13, 2016 at the above-referenced docket. PECO is seeking approval of the ANB contract and a waiver, to the extent necessary, of the requirement in the Phase III Implementation Order that the Company obtain advance Commission approval of its competitive RFP process.

Please note that this contract is CONFIDENTIAL and should be accorded confidential treatment by the Commission.

PECO has selected ANB for the provision of data tracking services in connection with all Phase III programs. Exelon Business Services Company issued a request for information for these services on February 3, 2016 and an RFP on April 15, 2016. The procurement was conducted in a manner consistent with PECO's Phase III Commission-approved RFP process. The ANB contract is consistent with the Commission's contract criteria in the Phase III Implementation Order.²
