

**PETITION TO WITHDRAW OF CITIZEN POWER, INC. AND NOTICE OF
CHANGE IN ADDRESS**

1. Citizen Power, Inc. ("Citizen Power") hereby Petitions to Withdraw from the above-captioned proceeding pursuant to the provisions of the Rules of Practice and Procedure of the Pennsylvania Public Utility Commission ("PUC" or "Commission"), 52 Pa. Code Section 5.94 and the Public Utility Code.
2. On September 25, 2009, Citizen Power Petitioned to Intervene in the above-captioned proceeding. This Petition was approved in a Prehearing Order on October 8, 2009, and subsequently Citizen Power has been an active participant in this proceeding.
3. Citizen Power is temporarily suspending legal advocacy operations effective October 31, 2016 due to funding shortages. Therefore, Citizen Power is unable to continue participating in this proceeding.
