- Briefly describe why you are interested in joining this Board.
- I have had the privilege of being an observer and sometime participant in the Board meetings, as the "principal investigator" for the Telecommunication Device Distribution Program (TDDP). I have been encouraged to see the Board's (and the PUC's) actions to promote access to telecommunications for all Pennsylvanians with disabilities, and to assure equitable access to 21st century technologies. The Board needs to have a full complement of members to function appropriately. In the years I have been involved with the Board, I have not known the Board to have a representative of the "speech impaired" community. I hope to fill that void.
- Briefly describe your skills or experiences that match the purpose and responsibilities of the Board.

As a speech-language pathologist whose whole career has focused on how technology empowers people with significant speech impairments, I believe I am uniquely qualified to serve on the Board. I have conducted training on the importance of telecommunications for people with communication disabilities, both pre-service and continuing education, especially for transitioning youth. I have provided testimony to the FCC on access to telecommunications for individuals with intellectual disabilities. In addition, my experiences with the TDDP and familiarity with the Board will make me a "quick study" to fulfil the role of an active member. I am well connected to the communities of people who serve individuals with hearing and speech – and other – disabilities who need to have access to telecommunications (e.g. Past President, PA Speech-Language-Hearing Association; previous chair and member of the licensing board (Board of Examiners in Speech-Language and Audiology; principal investigator, PA's Initiative on Assistive Technology, the commonwealth's Assistive Technology Act program; manager of the Harry M. activities under contract with the Office of Developmental Programs, serving individuals who are deaf or hearing impaired and who have intellectual disabilities; supervisor of iCanConnect PA, the National Equipment Distribution Program for the Deaf-Blind; [retired as of 11.30.2016]).

- Briefly describe what you expect to gain from being a member of this Board. I hope to continue my ability to be an effective advocate for people with disabilities, and to improve access to telecommunications for all.
- Explain your involvement, describe the benefit the community you represent would gain from membership to this Board, and how you best represent the deaf, speech impaired, deaf blind or hard of hearing community.

People with speech impairments are often challenged by face-to-face communication and are doubly affected by issues related to distance communication. Unfortunately, speech-to-speech is not well known in this community, or is felt to be ineffective. I hope to better understand the reasons for this and the extent to which new technology developments offer opportunities to people who rely on augmentative communication, and convey this information to the Board and the PUC.
