Secretary Chiavetta:

Enclosed for filing on behalf of UGI Penn Natural Gas, Inc. (“UGI PNG” or “the Company”) are originals of Tariff Gas – PA P.U.C. Nos. 9 and 9-S, seeking a general rate increase pursuant to 66 Pa.C.S. § 1308; UGI PNG Tariff Gas – PA P.U.C. No. 1 is also being withdrawn as part of this filing. Also enclosed is an original Statement of Reasons along with the supporting data and testimony, including data required by 52 Pa. Code §§ 53.52 and 53.53. Electronic copies of all the documents submitted in support of this filing are provided on the enclosed discs.

In this filing, UGI PNG is proposing to increase its annual jurisdictional revenues by approximately \$21.7 million, or by 10.4%. Even if the proposed increase is granted by the Commission, the average monthly residential heating customer bill will be 39% lower than the average bill following UGI PNG’s last rate case in 2009. UGI PNG is proposing that the new distribution rates become effective for service rendered on or after March 20, 2017.


