Dear Secretary Chiavetta:

The Pennsylvania Public Utility Commission (“Commission”) granted Dominion Retail, Inc., (“Dominion Retail”) a license as a natural gas supplier, at Docket No. A-125002. On October 8, 2009, Dominion Retail, Inc. provided the Commission notification that it had registered an additional fictitious name for the company, “Dominion Energy Solutions” under which it would thereafter transact business in the Commonwealth of Pennsylvania.


The purpose of this letter is to inform the Commission that on May 12, 2017, the corporate name of Dominion Retail, Inc. was changed to Dominion Energy Solutions, Inc. This change is evidenced by **Exhibit A**, which is the Certificate of the Delaware Secretary of State. Dominion Energy Solutions, Inc. subsequently filed the requisite documents with the Pennsylvania Department of State, noting the change in corporate name. The Department of State certificate of filing, dated on July 18, 2017, is attached hereto as **Exhibit B**.

Effective immediately, the corporate name of Dominion Retail, Inc. d/b/a Dominion Energy Solutions, has been changed to Dominion Energy Solutions, Inc. Because Dominion Energy Solutions was previously registered in the Commonwealth as a trade name, it will not change the name under which Dominion Energy Solutions, Inc. will transact business and will not affect customers in any fashion. SECOND: the certificate of incorporation of the corporation is hereby amended by striking out Article FIRST thereof and by substituting in lieu of said Article the following new Article:


"ARTICLE I: The name of the corporation is
