
Dear Mr. Kanagy,

On July 27, 2017, Laurel Pipeline Company, L.P. ("Laurel") served a request for production of documents on Monroe Energy, LLC. The request was made under 52 Pa. Code §§ 5.343(d) and 5.349 and demanded production of documents covering the same broadly defined categories as those stated as the areas of inquiry for the simultaneously noticed deposition of Ms. Tracy Sadowsky. On August 3, 2017, Monroe served objections to the notice of deposition/request for production of documents, that include an objection to category 5 of the list. Monroe has reviewed its files and has located one document that is responsive to the request for production that has not yet been provided to Laurel.
