Request to Withdraw Natural Gas Authority**

Dear Secretary,

Licensee requests the Pennsylvania Public Utility Commission ("Commission") withdraw Licensee's natural gas supplier authority granted in Docket A-125130.

On August 1st 2017, there was an organizational restructuring which merged the Licensee with and into Constellation NewEnergy – Gas Division, LLC ("CNEG") with CNEG being the surviving entity. CNEG is a licensed third party supplier of natural gas (Docket A-125095). The Licensee notified the Commission on August 28th 2017 with the details of the merger.

Licensee requests the Commission to take note of the following:

- In as much as Licensee was merged with and into CNEG, the entity attached to the license granted in Docket A-125130 no longer exists.
- There are no tax issues with the Pennsylvania Department of Revenue as the gross receipts tax is not applicable to natural gas sales.
- Notice of this request is being concurrently sent to the statutory agencies.
- There are no open issues regarding contracts or agreements as CNEG has assumed all obligations.

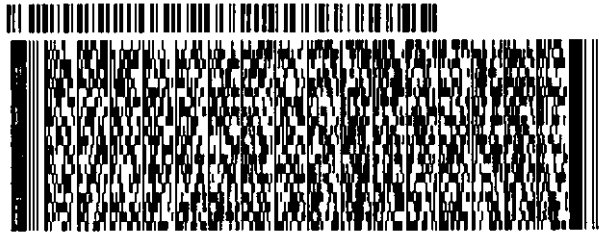

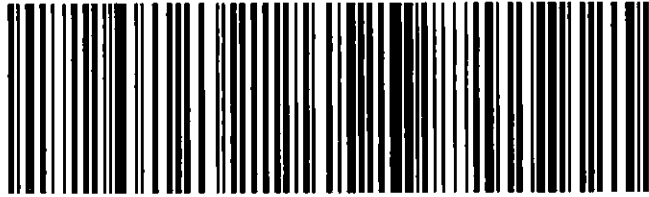
