PREHEARING MEMORANDUM OF THE COALITION FOR AFFORDABLE UTILITY SERVICES AND ENERGY EFFICIENCY IN PENNSYLVANIA

The Coalition for Affordable Utility Services and Energy Efficiency in Pennsylvania ("CAUSE-PA"), through its counsel at the Pennsylvania Utility Law Project, hereby files this Prehearing Memorandum pursuant to the December 8, 2017 Prehearing Conference Order issued by Administrative Law Judge Benjamin J. Myers.

I. Background

On March 17, 2016, the Commission issued an Opinion and Order at this docket which approved, in part, PPL Electric Utilities Corporation's (PPL or the Company) Act 129 Phase III Energy Efficiency and Conservation Plan, as modified by a Joint Petition for Approval of Partial Settlement. CAUSE-PA was an active party to the underlying proceeding,¹ and was a signatory to the Joint Petition for Approval of Partial Settlement.

On June 6, 2017, PPL Electric Utilities Corp. (PPL or the Company) filed at this docket a Petition for Approval of Changes to its Act 129 Phase III Energy Efficiency and Conservation Plan (Petition). Comments to PPL's proposed amendments were filed by the Office of

Consumer Advocate (OCA), PP&L Industrial Customer Alliance (PPLICA), the Keystone Energy Efficiency Alliance (KEEA), and the Pennsylvania Energy Efficiency for All Coalition (PA-EEFA), and Reply Comments were filed by PPLICA and PPL. On October 26, 2017, the Commission issued an Opinion and Order, which approved PPL's proposals, in part, but referred the following proposed Plan change to the Office of Administrative Law Judge for hearings and a recommended decision:

Allow for Enhanced Incentives for Localized Energy efficiency or Demand Reduction to be Offered as a Pilot under the Appliance Recycling, Energy Efficient Home, Demand Response and Nonresidential Energy Efficiency Programs.

(Oct. 26 Opinion and Order at 42, ¶ 3.a). Pursuant to the October 26, 2017 Order, ALJ Myers issued a Prehearing Conference Order on December 8, 2017, and set a prehearing conference for February 7, 2018.

II. <u>Issues to be Presented</u>

As an active party in this proceeding, and a signatory party to the Joint Petition for Approval of Partial Settlement, CAUSE-PA has a critical interest in ensuring that PPL's Act 129 Phase III Plan is not modified in a way which would harm low income households. Our participation in this proceeding is narrowly focused to protect that interest and, more specifically, to ensure that decisions made through the course of this proceeding will not negatively impact the adequacy and accessibility of Act 129 energy efficiency programming to low income consumers in PPL's service territory.

III. <u>Witnesses and Testimony</u>

At this time, CAUSE-PA has not identified a witness to provide testimony on its behalf in this proceeding, but reserves the right to identify a witness if warranted through the course of the proceeding, upon proper notice to Your Honor and the parties.

IV. Proposed Schedule

CAUSE-PA is prepared to work with the parties to identify a mutually agreeable

schedule that is also acceptable to ALJ Myers.

V. <u>Settlement</u>

CAUSE-PA is prepared to work with the parties to achieve a settlement in this

proceeding, and notes that active settlement discussions are underway.
