2. My interest in this project is: *Our property is not slated to be affected by the project, but as owners of a farm adjacent to properties that are threatened by the plan, we wish to support our neighbors in expressing our extreme antipathy to the disruption of our beautiful community.*

3. Existing participants in the filing may not understand: *Both of us have family roots in Lower Chancery township that date back hundreds of years: the Kennedys, whose patriarch emigrated from Ireland in 1840, and the Stewarts can be traced back to pre-revolutionary times. Two of our children have homes and land on the family farm, and some of the grandchildren have expressed wishes to also live in this area. We feel that this transmission line will very negatively affect the quality of life, and the value of land in the area.*
