**PREHEARING MEMORANDUM
OF THE SUSTAINABLE ENERGY FUND**

The Sustainable Energy Fund of Central Eastern Pennsylvania (“SEF”) hereby submits its prehearing statement pursuant to the December 8, 2017 Prehearing Conference Order issued in the above-captioned proceeding:

I. INTRODUCTION AND HISTORY

On November 30, 2015, PPL Electric Utilities Corporation (“PPL”), filed with the Commission its petition for the approval of its Act 129 Phase III Energy Efficiency and Conservation Plan (“Phase III Plan”).

On June 6, 2017, PPL filed a Petition for Approval of Changes to its Act 129 Phase III Energy Efficiency and Conservation Plan (“Petition”) wherein it sought to make changes to its filed Phase III Plan.

On July 6, 2017, comments to PPL’s Petition were filed by the Office of Consumer Advocate (“OCA”), the Pennsylvania Energy Efficiency for All Coalition (“PA-EEFA”), the Keystone Energy Efficiency Alliance (“KEAA”), and the PP&L Industrial Customer Alliance (“PPLICA”).

On July 26, 2017, PPL and PPLICA filed reply comments.

On November 21, 2017, the Commission approved all but one of PPL's proposed changes to its Phase III Plan. For the lone issue not approved, the Commission assigned it to Administrative Law Judge Benjamin Myers for an evidentiary hearing limited to the following:

Proposed Change No. 10 – Allow for Enhanced Incentives for Localized Energy efficiency or Demand Reduction to Be Offered as a Pilot under the Appliance Recycling, Energy Efficient Home, Demand Response and Nonresidential Energy Efficiency Programs.

II. ISSUES

Pursuant to the Commission's Order dated November 21, 2017, the lone issue presented in this proceeding is PPL's Proposed Change No. 10 as stated above.

III. WITNESSES

At this time, SEF has not determined whether it will present a witness. SEF reserves the right to present a witness in this proceeding. If a witness is required, SEF will promptly alert ALJ Myers and the Parties. Additionally, SEF reserves the right to cross examine any witness presented by any of the other Parties.


V. **PROPOSED SCHEDULE**
