- We, Roy and Emma Cordell, own a tract of farm land on which Transource proposes to site the powerline.
- 3. The proposed right of way cuts off access to our fields on three sides. The construction of the powerline, if it goes through, will have a major impact on our farming operations, as it crosses the middle of all our strips of farm land save one. All fields are entered from Fetterhoff Chapel Rd (a state road) and Altenwald Rd. (a township road). I am very concerned that during the construction phase my access to part of my fields will be blocked by the construction path. I am also concerned that I will not be adequately compensated for the long-term damage to my soil (which is Duffield loam (some of the richest in the US), due to compaction during construction of, and during ongoing maintenance of the power line right of way. I also know from my farming experience that tilling and working fields around power poles a creates a hindrance to good, efficient farming practices. The

proposed route also crosses over a permanent pasture field, where I regularly have diary heifers pastured. I think the construction and the existence of a high voltage power line will have a deleterious effect on the animals which could harm their health and cause a loss of value to the livestock.

WHEREFORE we, Roy and Emma Cordell, respectfully requests the Pennsylvania Public Utility Commission not to approve the Independence Energy Connection West project and to hold full and public hearings on the project here in Franklin County near the site of the proposed project.
