PROTEST

2. I am a resident and homeowner of Fayetteville, in Franklin County, PA.

I am a citizen in good standing of the Commonwealth of PA.

I am a rate payer of electricity.

3. My fellow citizens and I have individual rights, under both the state and federal auspices.

Specifically, Article 1, Section 27 of the PA Constitution states:

The people have a right to clean air, pure water, and to the preservation of the natural, scenic, historic and esthetic values of the environment. Pennsylvania's public natural resources are the common property of all the people, including generations yet to come. As trustee of these resources, the Commonwealth shall conserve and maintain them for the benefit of all the people.

(May 18, 1971, P.L.769, J.R.3)

4. My husband and I recently purchased a home in Penn National. One of the many draws of buying real estate in Franklin County is the beauty of the surrounding region: the rural vistas, the views on a Sunday drive, the hiking trails, and the emphasis on nature and rural life that is so evident throughout. Allowing any company to ruin the green farmland, privately owned land, and the overall look of our valley should NOT be allowed.

This project will have zero benefit to Franklin County and will only spoil our natural environment and have a detrimental effect. I hope that you agree that the rights of tax-paying citizens to keep their land and the natural majesty of their surroundings far outweighs some company making profits through this unnecessary project. Since I also exercise- hike, bike, and jog- all over the region, I will be directly affected. I am concerned about the safety of high voltage power lines, and how excavation and the actual building of such monstrosities will damage green areas and be an undue burden on local roads and traffic.

Lastly, I would like to mention that I am a public school teacher. As an adult, I know that I am fortunate enough to live in one of the most beautiful and unspoiled places in the world. I think we all owe it to our childen to allow them to grow up in this way, in this area, as well. We all have individual rights to the life, liberty, and the pursuit of happiness, at a federal level.
