3. The grounds for our protest of this proposal:

It is very inconvenient to farm around towers. I did not buy property to share property and ruin future plans. It is very limiting on the options for a farm building and further expansion of our operation.

4. This directly affects me by less acreage for production. We have a private place for family to gather and enjoy scenery and the outdoors that would not be as enjoyable looking at power lines and hearing the unpleasant hum. It has put the burden on me to use my time to get informed about the project in which facts are not forthcoming, like substation getting fed from or going to a big city or power station. This is only the beginning and there will be more power lines and many problems to follow.

WHEREFORE, Douglas E. Rohrer respectfully requests Pennsylvania Public Utility Commission to fully investigate the costs and benefits of the filing, strongly impose a condition that all other existing rights of way and infrastructure should be utilized before any new power line projects are approved, and **the Commission should deny the Transource filing.**


