## **PROTEST**

2. The Protestant is a property owner at the Penn National Golf Course, 7205 Fairway Drive South, Fayettevile in Franklin County, Pennsylvania.

3. The Protestant is filing this Protest over concern about the thoroughness of the assessment to justify this project, the project's impact to the economy and environment of Franklin County, and the future value of the Protestant's land and future home.

4. The Protestant is concerned over the lack of a thorough examination for the need for this project. Power delivery is normally reliable. This project negatively impacts property owners, particularly farmers. They incur not only the reduction but also the devaluing of their property. It is unclear if renewable energy options were considered to address this market efficiency need. The project also doesn't address upgrading transmission lines in existing rights-of-way. Also, it is unclear if local solutions in the Baltimore –DC-Northern Virginia area were considered. Energy power generation and storage is improving. Using antiquated methods is inefficient. The Protestant is also concerned about the overall negative economic impact to Franklin County. While the project may create jobs during construction, the project negatively impacts personal property values, the agriculture sector and the tourism sector of the Franklin County economy.

WHEREFORE, Maria S. Whalen respectfully requests the Pennsylvania Public Utility Commission not to approve this project as it is currently filed in order to further investigate the costs and benefits of the project to the people of Franklin County, and to fully consider renewable energy options as well as local solutions for the communities that are the stated beneficiaries of this project.
