On April 12, 2018 we received a data request (The Notice) regarding our Act 127 Report Operator Annual Report Form. The Notice requested explanations of differences between 2016 and 2017 calendar years. While a full comparison of the differences is listed below, there was one error found in our report. The Wyoming County mileages were listed on the Westmoreland County line. A corrected report has been submitted.

The counties listed in the notice were as follows: Beaver, Bradford, Greene, Sullivan, Susquehanna, Washington, and Westmoreland. As it has been noted, Westmoreland county mileages have been replaced with Wyoming. All counties mileages changes are caused by changes in class location, mapping system changes, or new pipe being installed.


