
Dear Secretary Chiavetta:

Enclosed for filing on behalf of Duquesne Light Company ("Duquesne Light" or the "Company") are Duquesne Light Exhibits RLO-5 and RLO-6. Exhibit RLO-5 contains an update of certain filed schedules for the Fully Projected Future Test Year ended December 31, 2019 ("FPFTY"). An explanation of the updates contained in Exhibit RLO-5 are enclosed and marked as Exhibit RLO-6.

Exhibit RLO-5 updates the Company's accumulated depreciation balance, surcharge expenses, accumulated deferred income taxes, tax expense, common equity ratio, gross receipts tax expense and payroll tax expense adjustment for the FPFTY. Exhibit RLO-5 results in a net proposed revenue decrease of \$2,891,000.


