AMENDMENT TO COMPLAINT BY DUQUESNE INDUSTRIAL INTERVENORS

TO THE HONORABLE, THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

1. On May 7, 2018, pursuant to Section 701 of the Pennsylvania Public Utility Code, 66 Pa. C.S. § 701, and Sections 5.21 and 5.22 of the Pennsylvania Public Utility Commission's ("PUC" or "Commission") regulations, 52 Pa. Code §§ 5.21 & 5.22, the Duquesne Industrial Intervenors ("DII" or "Complainant") submitted its Complaint ("DII Complaint") against Supplement No. 174 to Tariff Electric – Pa. PUC No. 24 ("Supplement No. 174").

2. On May 3, 2018, Administrative Law Judge ("ALJ") Katrina L. Dunderdale consolidated the DII Complaint and five other complaints into Duquesne Light Company's ("Duquesne Light") rate proceeding docketed at No. R-2018-3000124.

3. On May 21, 2018, DII amended the DII Complaint to include Duquesne University and Linde Energy Services, Inc. as members of DII.

4. Since the submission of the May 21 amendment to the DII Complaint, Allegheny County Airport Authority ("ACAA") also joined DII for the purpose of participating in this proceeding. ACAA intends to participate in this proceeding as a member of DII. 5. ACAA is an energy-intensive institutional customer receiving electric service from Duquesne Light's service territory. ACAA takes service from Duquesne Light on several rate schedules, including Rates L and GL. Like other DII members, ACAA uses substantial amounts of electricity, and any modification to Duquesne Light's terms of service may have a significant impact on all DII members' cost of doing business.

6. Pursuant to Sections 5.91 of the Commission's regulations, DII hereby amends the DII Complaint, modifying Paragraph 1 and Appendix A of the DII Complaint to include ACAA as a member of DII.

7. Paragraph 1 of the DII Complaint shall be amended to read as follows:

The Complainant is DII, which, for purposes of this proceeding, includes:

Allegheny County Airport Authority (ACAA) Duquesne University Linde Energy Services, Inc. United States Steel Corporation University of Pittsburgh

Current members of DII are also listed in Appendix A attached hereto. DII will update Appendix A throughout the course of this proceeding, as necessary.

8. Appendix A of the DII Complaint shall be amended to include ACAA in its list of DII members for purposes of this proceeding. A copy of the amended Appendix A is attached hereto.

WHEREFORE, the Duquesne Industrial Intervenors request that the Complaint of the Duquesne Industrial Intervenors be amended as described herein, that Duquesne Light Company be required to answer this Complaint, as amended, and that upon a final hearing, the Pennsylvania Public Utility Commission make such Order as it deems necessary and appropriate.
