On June 7, 2018, a Joint Petition for Resolution of Proceedings and Amendment of Orders was filed in the above-captioned proceeding by Aqua Pennsylvania Wastewater, Inc. ("Aqua"), Limerick Township ("Limerick"), and the Office of Consumer Advocacy ("OCA"). A Settlement of this proceeding was entered into by Aqua, Limerick, and OCA. As it is the position of the Bureau of Investigation and Enforcement ("I&E") that the acquisition does not meet the requirements set forth under 66 Pa. C.S. § 1102, I&E was unable to be a signatory to this Settlement. I&E respectfully opposes the Settlement because the requisite affirmative public benefits are simple not present in this acquisition.
