Our County is curious about the order made by Administrative Law Judge Barnes to overturn the Commission's May 3rd 5-0 ruling to allow Mariner East 1 to resume service. A consensus decision made by the Board of Commissioners should be final.

Our local experience in working with Sunoco has made a real effort to assure safety of our County, and provide additional education opportunities to our first responder's community.


