SECOND PREHEARING CONFERENCE MEMORANDUM OF YORK COUNTY PLANNING COMMISSION

TO: THE HONORABLE ELIZABETH H. BARNES THE HONORABLE ANDREW M. CALVELLI Pursuant to Presiding Administrative Law Judges Elizabeth H. Barnes and Andrew M. Calvelli's June 26, 2018 Third Prehearing Order and 52 Pa. Code § 5.222(d), York County Planning Commission (YCPC), by and through its attorneys, Hawke McKeon & Sniscak LLP, respectfully submits this Second Prehearing Conference Memorandum in the above-captioned proceeding before the Pennsylvania Public Utility Commission (the Commission).

I. CONSOLIDATION OF CASES

The Third Prehearing Order appears to have already consolidated all of the Commission proceedings related to Transource Pennsylvania, LLC's (Transource) Application.

II. ISSUES

The YCPC incorporates the issues raised in its first prehearing conference memorandum filed March 9, 2018.

III. FEASIBILITY OF ALTERNATIVE SITING ROUTES INCLUDING THE USE OF EXISTING TRANSMISSION LINES OWNED BY PPL ELECTRIC CORPORATION, MID-ATLANTIC INTERSTATE TRANSMISSION, LLC, FIRSTENERGY COMPANY AND/OR PECO ENERGY COMPANY

The YCPC supports the use of alternative routes that utilize existing transmission lines instead of the proposed construction of additional transmission lines.

IV. DISCOVERY ISSUES INCLUDING OCA'S ACCESS TO PROMOD, A SOFTWARE MODEL USED BY PJM AS PART OF ITS MARKET EFFICIENCY ANALYSIS

The YCPC has not requested access to PROMOD, but supports the OCA's efforts and is willing to extend the schedule as necessary for OCA to obtain discovery and information as necessary.

V. STATUS OF TECHNICAL CONFERENCE WITH REPRESENTATIVES FROM TRANSOURCE AND/OR PJM

The YCPC takes no position on this issue.

VI. AMENDMENTS TO THE PROCEDURAL SCHEDULE

The YCPC supports the OCA's proposed schedule.
