I am writing you as chair of, and on behalf of, the members of the Telecommunications Relay Services (TRS) Advisory Board. On May 9, 2018 the TRS Advisory Board ("the Board") met and discussed the report submitted by the Institute on Disabilities at Temple University on the results of the Wireless Expansion Initiative (WEI). This pilot program serving the southeastern Pennsylvania region explored the impact of distributing wireless devices for telecommunications on individuals with disabilities meeting the eligibility requirements for the Telecommunication Device Distribution Program (TDDP) established by Act 34 of 1995. After due consideration of the findings and recommendations in the report, the Board advises the Public Utility Commission of its desire that the TDDP be expanded statewide to include wireless telecommunications devices - only; (NOT voice or data services) for Pennsylvanians with disabilities who meet all other TDDP eligibility criteria. The TRS Board suggests the PUC provide an opportunity for people with disabilities who would benefit from such a program to share their comments in this regard.
