1. My name is Matthew Gordon. I am employed by Sunoco Pipeline L.P. ("SPLP") and currently serve as the Senior Director for the Mariner East 2 and 2X pipeline project.

2. SPLP has provided provide all engineering documents and plans to Richard Kuprewicz of Accufacts, Inc. for safety reviews related to Mariner East 2 and Mariner East 2X between the valve at Eagle and the valve at Middletown, and regarding Sunoco Pipeline L.P.'s plans to eliminate a valve in West Goshen Township and automate a valve approximately 2.5 miles from West Goshen Township. Specifically:

- a. On July 18, 2018, I contacted Mr. Kuprewicz to understand the data he required.
- b. On August 20, 2018, I submitted initial documents to Mr. Kuprewicz.
