Dear Secretary Chiavetta:

We are counsel for the City of Reading ("City") in the above consolidated proceedings involving complaints against UGI Utilities, Inc. ("UGI").

The City's Main brief was filed on October 18, 2018 in accordance with the schedule set forth in Judge Long's Interim Order of August 27, 2018 and contained proposed Ordering Paragraphs in Appendix C. At the request of our client, we wish to make clear that adoption of proposed Ordering Paragraph Nos. 3 and 4 in Appendix C of the City's Main Brief would be without prejudice to the City's ability to participate in any proceeding involving vehicular damage that may have been anticipated under 49 CFR § 192.353 for meters installed prior to September 13, 2014 and without prejudice to the City's ability to participate in any proceeding that would require UGI to recognize districts in Reading that are or become eligible for historic designation.

This does not change the updated Joint Stipulation that was filed on August 28, 2018 or the City's agreement therewith, nor does it require any change in proposed Ordering Paragraphs 3 and 4. This letter is being submitted for clarification purposes only well in advance of the filing date for UGI's brief in this proceeding
