At its August 23, 2018 meeting, the Metropolitan Edison Company/Pennsylvania Electric Company Sustainable Energy Fund Advisory Board nominated Mr. Woodwell and the nomination was unanimously approved. This position was advertised through a variety of sources, including fund web sites, newsletters of the community foundations where the funds are held, and on the PUC's website for periods of more than 30 days in spring 2018. 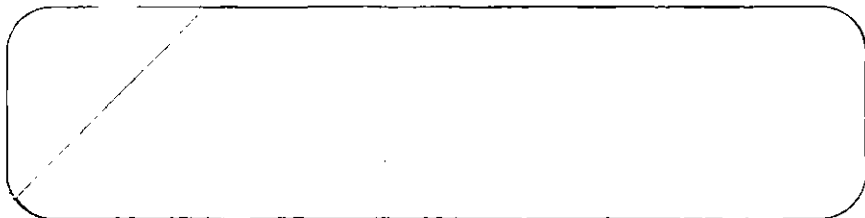
