**SUNOCO PIPELINE L.P.'S ANSWER OPPOSING  
INTERVENTION OF DELAWARE COUNTY<sup>1</sup>**

---

Pursuant to 52 Pa. Code § 5.66,<sup>2</sup> Sunoco Pipeline L.P. (SPLP) submits this Answer Opposing Delaware County's February 22, 2019 Petition to Intervene in this proceeding because the Petition is untimely and Delaware County has not shown its interests are not adequately represented.

1. On November 19, 2018 Complainants filed the Complaint and Petition.
2. On December 20, 2018 Complainants filed an Amended Complaint.
3. Delaware County filed a Petition to Intervene on February 22, 2019.

<sup>2</sup> SPLP notes that it is not required to specifically answer the allegations within a Petition to Intervene, and any such allegations are not deemed admitted by SPLP's non-response. Compare 52 Pa. Code § 5.66 ("party may file an answer to a Petition to Intervene within 20 days of service, and in default thereof, may be deemed to have waived objection to the granting of the petition. Answers shall be served upon all other parties.") with § 5.61(b)(3) (as to form of answers to complaints, answers must "Admit or deny specifically all material allegations of the complaint").

4. Delaware County's Petition is untimely. It was filed 95 days after the Complaint and 64 days after the Amended Complaint.

5. Delaware County falsely alleges that its Petition was timely filed citing 52 Pa. Code § 5.53. *See* Petition to Intervene at 20.

6. 52 Pa. Code §§ 5.74 and 5.53 require a petition to intervene in a proceeding be filed within 60 days of the initiating pleading in a proceeding, absent "good cause shown."

7. Delaware County's Petition was untimely because it was filed 95 days after the Complaint and Delaware County has not averred good cause for allowing untimely intervention.

8. The December 20, 2018 amendments to the Complaint did not extend the time for interventions. Even if there was a Commission regulation that extended the time for intervention based on an amendment to a pleading, which there is not, SPLP notes that Delaware County's Petition to Intervene would still be untimely, as it was filed 64 days after the Amended Complaint was filed. There is no Commission regulation that extends the time for intervention when an amendment to a pleading is filed. A petition to intervene is due 60 days from an initiating complaint. 52 Pa. Code §§ 5.74 and 5.53.

9. In contrast, the Commission's regulations expressly extend the answering time period when an amended pleading is filed to require an answer within 20 days of the amended pleading. 52 Pa. Code § 5.65(a). The presence of a specific Commission regulation that extends the time for an answer in the event of an amended pleading coupled with the absence of any Commission regulation regarding intervention and amended pleadings means that the Commission has not changed the time period for intervention in the event of an amended pleading. *See, e.g., Popowsky v. Pennsylvania Public Utility Com'n*, 869 A.2d 1144, 1159 (Pa. Cmwlth. 2005) (the inclusion of a specific matter in a statute implies the exclusion of other matters).

10. To allow untimely intervention, the petition to intervene must show good cause. 52 Pa. Code § 5.74.

11. Delaware County fails to even allege good cause for allowing it to intervene out of time in this proceeding. There is no good cause to allow Delaware County to intervene out of time and its Petition should be denied.

12. Moreover, upon information and belief, Delaware County knew about the Complaint and even discussed the contents of the Complaint at County Council meetings. The County Council has had active discussions of the Mariner East pipeline system involving two of the Complainants, Ms. Nancy Harkins and Ms. Rosemary Fuller. *See* Attachment A, the December 5, 2018 County Council Meeting Minutes. While the minutes do not show precise discussion of filing a Petition to Intervene, it shows active discussion of the Complainants claims echoing their Complaint presented to the County Council. Therefore, the Delaware County Council had knowledge of the Complaint, and cannot show good cause necessary for an untimely intervention.

13. Further, the Delaware County Council formally discussed filing a Petition to Intervene on February 6, 2019 at the County Council meeting. *See* Attachment B, a copy of the February 6, 2019 meeting minutes. When considering filing a Petition to Intervene, Councilman Kevin Madden stated the following:

**“This is a petition that has been in the public domain for 2 months, we’ve had numerous conversations in County Council meetings about it.”**

*See* the publicly available recording of the February 6, 2019 meeting, Mr. Madden’s statement at

Therefore, upon information and belief, Delaware County knew about, considered, yet actively chose not to file their petition to intervene within the 60-day period described in 52 Pa. Code §§ 5.74 and 5.53. Delaware County's petition to intervene should be denied as no good cause can be shown for its untimely intervention.

14. Delaware County's Petition to Intervene should also be denied because it has failed to show that its interests are not already adequately represented in this proceeding. 52 Pa. Code § 5.72 (a)(2); *see generally* Petition to Intervene.

15. Indeed, Delaware County merely states its interest "... cannot be, adequately represented by any other party." Petition to Intervene at ¶ 17. However, 52 Pa. Code § 5.72(a)(2) expressly provides that to intervene, petitioner must possess "an interest which may be directly affected **and which is not adequately represented by existing participants.**" *Id.* (emphasis added). Delaware County has not provided any reason or support for the notion that their interests are not adequately represented by existing participants. Accordingly, Delaware County's Petition to Intervene should be denied on this basis as well.

16. SPLP notes that if Delaware County is nonetheless granted intervenor status, late filed intervenors must take the case as it is and cannot expand the scope of the proceeding. *See Com., et al. v. Energy Services Providers, Inc. d/b/a PaG&E, Order Granting Petition to Intervene*, Docket No. C-2014-2427656, 2015 WL 1957859 (Order entered Apr. 23, 2015) (Cheskis, J.) ("In granting intervention, however, Mr. Sobiech will be required to take the case as it currently stands. PaG&E is correct that intervenors generally take the record as they find it at the time of intervention."). Even if intervention is allowed, Delaware County cannot pursue issues beyond the scope of the Amended Complaint.

**WHEREFORE** Sunoco Pipeline L.P. respectfully requests Delaware County's Petition to Intervene be denied.

The Regular Meeting of Delaware County Council was held on December 5, 2018 at 10:00 A.M. in the County Council Meeting Room, Government Center Building located at 201 W. Front Street, Media, PA. Chairman McBlain called the meeting to order followed the Pledge of Allegiance to the flag. Lisa Casey, of the Office of Veterans Affairs, gave the invocation.

Chairman McBlain asked for a moment of silence in observance of the passing of former President George H.W. Bush on Friday, November 30.

Chairman McBlain called on Vice Chairman Morrone to start today's Agenda Items.

Motion made by Mrs. Morrone approving the Minutes of the Regular Meeting of November 28, 2018 with one correction made by Chairman McBlain, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agenda Item 5, a Professional Services Agreement with Honorable Charles B. Burr, II, in an annual amount of \$60,000.00. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agreements, Contracts and Amendments with the Human Services Providers of Services as per the attached list. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Resolution 2018-10, in accordance with Section 147(f) of the Internal Revenue Code of 1986, as amended, Revenue Bonds in an aggregate amount to \$9,000,000.00 by the Saint Mary Hospital Authority to provide funds to Trinity Health Corporation and Mercy Fitzgerald Hospital to refinance the construction, renovation, expansion, equipping and furnishing of the Health Care Facilities of the hospital, and determining that the refinancing of the project through the issuer will promote health, safety and welfare of the people of the area. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving to renew the Service and Support Agreement with MTS Software Solutions for a one-year period from 1/1/2019 through 12/31/2019 at a cost of \$165,257.42. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving to Award Contract to Carpet Fair, Inc. to furnish and install carpet tiles, plus take-up and dispose of existing floor covering in various areas of County



Government for a two (2) year period. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving to renew an Agreement between the County of Delaware and Elwyn Employment Services to provide Custodial Services to the Curran and Fronfield Buildings for a term of one (1) year beginning January 1, 2019 to December 31, 2019 in the amount of \$91,920.27. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Resolution 2018-11, the adoption of the Little Flower Master Site Development Plan. The County certifies that the project was completed in accordance with the DCNR Grant Agreement; that all project expenditures have been made and were in accordance with the Grant Agreement; that the Plan and related materials are acceptable to the County of Delaware; and the Plan and related materials will be used to guide future recreation and conservation decisions. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agenda Item 12 to Advertise for Bids for repair and/or replacement of Roof for the Woodburne Mansion located at the Little Flower Park. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving a Grant to the Economic Development Oversight Board for the calendar year 2019 in the amount of \$655,200.00. (Restricted Gaming Funds) The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried with an abstention vote cast by Chairman McBlain as the law firm where he is employed has provided legal services for the Economic Development Oversight Board. (Vote: 4 Yeas, 1 Abstained)

Chairman McBlain called on Solicitor Maddren to speak on Agenda Item 14, the First Reading of Ordinance 2018-2, the 2019 County Budget.

Solicitor Maddren said today was the day advertised for the First Reading of Ordinance 2018-2, which is the County Budget and Tax Levy Ordinance.

This Ordinance sets an Operating Budget of \$354,877,000.00 and a Capital Spending Program of \$177,367,000.00 for the years 2019 through 2023. The Budget has been and remains available in both the Office of County Budget Management and the Office of the County Clerk.

This Budget equates to a "no increase" tax millage of 4.679 mills or \$.4679 on each one-hundred dollars on assessed valuation for the Operating Budget and a millage of .925 mills or \$.0925 on each one-hundred dollars of assessed valuation for the Capital Spending Program for a total millage of 5.604 mills or \$.5604 on each one-hundred dollars of assessed valuation.

County Council is holding a hearing on this Budget to obtain public comment tonight in this meeting room at 6:00 P.M. This has also been advertised. A copy of this Ordinance is available in the County Clerk's Office.

Solicitor Maddren said this concludes the First Reading of Ordinance 2018-2.

Motion made by Mrs. Morrone approving the request by the Controller's Office for payment of current bills, seconded by Mr. Culp and carried unanimously.

**SOLICITOR:** Mr. Maddren said he had no further County business to report or request today.

**PUBLIC COMMENT:** George Alexander, 437 E. Franklin Street, Media, spoke regarding the Risk Assessment of the Mariner East 2 Pipeline.

Nancy Harkins, 1521 Woodland Road, West Chester, PA, also spoke regarding the Risk Assessment Study.

Rosemary Fuller, 226 Valley Road, Media, spoke regarding the Mariner East 2 Pipeline evacuation and safety plan.

Elizabeth Maguire, Friends of the Woodburne, thanked County Council for the Little Flower Park and all the hard work that went into the planning.

Mitch Trembicki, 187 Middletown Road, Glen Mills, spoke regarding the Mariner East 2 Pipeline Risk Assessment Study and the evacuation and safety plan.

**COUNCIL:** Mr. Zidek posed a question to Executive Director Grace as to when G2 would provide a public presentation of their Risk Assessment Study. Mrs. Grace said they are working with the contractor to have a public meeting with a goal of having this done within the next couple of weeks.

Mr. Zidek said the public can be assured that when we have a date we will let everyone know. The goal would be to have the engineers present their report so that we can make sure we have a common understanding of what it says and (presumably) also to provide us with an opportunity to ask questions of the engineers.

From his own perspective, he would like to speak briefly about the Risk Assessment Report. Thus far, it's been useful. One of the issues that he heard loud and clear shortly upon taking office was that the citizens of Delaware County just didn't know how risky the pipeline was. Some of them feared it was very risky and some told us it wasn't risky at all. The Risk Assessment Study is useful in providing some objective analysis of what that risk is. People will

differ on their tolerance for risk and their views as to what is too risky and what isn't and that is understandable and expected. That's human nature, but at least we have a starting point to understand what objectively the risks are.

The other element to that is what he is concerned with from jump (with regard to the pipeline) is making sure our first responders had enough information to adequately prepare evacuation plans in conjunction with schools, hospitals, nursing homes and with individual citizens. He hopes that this Risk Assessment and the work that will hopefully stem from it will enable better and more robust and transparent evacuation plans and contingency plans to be developed by our first responders so that the citizens of Delaware County can be made safe and so our first responders can have what they need so they can do their job safely.

Mr. Madden wished to add his voice to the many people who have recognized the passing of our late President George H.W. Bush. When we lose a great man, it is important to reflect on what made him great and to look at those aspects of his life that are relevant today. He says that, acknowledging that we do not need to agree with every single action of a person who is tasked with making one difficult decision after another. But when you look on late President Bush's life, he wanted to highlight a few things.

This is someone who answered the call to action for his country repeatedly. First, as enlisting as a fighter pilot in World War II in the Pacific front and then committing his life to public service, which is never an easy one to do. It is a difficult decision and he answered that repeatedly. It is something we all need to be doing in this modern world we are living.

Second, he did what he felt was right regardless of what the political ramifications were. He made decisions during his career that (frankly) cost him his career, but he did it because he felt it was the right thing to do. It is a political bravery that we so often miss today.

Lastly, Mr. Madden said President Bush recognized the importance of his role and his place as role model. He carried himself with grace and with dignity that is so important in setting that role model for everyone who observed him. Thanks to President Bush for everything he meant to our country.

Mr. Culp wanted to publicly thank Budget Director Jim Hayes, Jim Hackett and Sue DePompeo for all the hard work they did in getting the Budget together. They are an asset to Delaware County. He looks forward to discussing the Budget with the public tonight.

Chairman McBlain shared a short story about President Bush when he was running for re-election in 1992 and came to Delaware County on a campaign visit when he recognized two veterans in the crowd and gave them a salute.

Lastly, Chairman McBlain reminded everyone about the Budget Hearing that will take place tonight at 6:00 P.M. in this meeting room.

There being no further County business, nor public discussion, motion made by Mr. Culp to adjourn the meeting, seconded by Mr. Madden and carried unanimously.
