Matthew Gordon states as follows:

1. My name is Matthew Gordon. I am employed by Sunoco Pipeline L.P. (“SPLP”) and currently serve as the Senior Director for Operations. I was previously the Director for the Mainer East 2 and 2X pipeline project and continue to serve as a company representative for the project.
  
2. The purpose of this Affidavit is to update and amend the affidavit I submitted on October 19, 2018 as follows:
  
3. SPLP has provided provide all required engineering documents and plans to Richard Kuprewicz of Accufacts, Inc. for safety reviews related to Mariner East 2 between the valve at Eagle and the valve at Middletown, and regarding SPLP’s plans to eliminate a valve in West Goshen Township (WGT) and automate a valve approximately 2.5 miles from WGT on Mariner East 2.

4. Regarding Mariner East 2X, that pipeline and related facilities remain in the design and permitting phase for the relevant geographic area. After consultation with Mr. Kuprewicz and counsel for WGT, SPLP and WGT agreed that required information for Mariner East 2X will be provided to Mr. Kuprewicz subject to a non-disclosure agreement once final for efficiency of Mr. Kuprewicz's review process.

5. I understand that the statements set forth herein are made subject to 18 Pa. C.S. § 4904 relating to unsworn falsification to authorities.
