The purpose of this letter is to notify the Public Utility Commission that the Tenant Union Representative Network and Action Alliance of Senior Citizens of Greater Philadelphia (“TURN et al.”) do not oppose the Joint Petition for Partial Settlement, which was filed today in this proceeding.

TURN *et al.* actively participated in settlement negotiations in this proceeding and are optimistic that, if approved, the partial settlement will help mitigate the impact of a rate increase on low-income consumers. We also believe that the partial settlement addresses some of the concerns facing low-income consumers during the COVID-19 pandemic. While we were ultimately unable to join the settlement, we do not oppose it.


