UGI Utilities, Inc. – Gas Division ("UGI Gas") hereby files Supplement No. 16 to UGI Gas – Pa. P.U.C. No. 7 in accordance with Commission Order at Docket No. R-2018-3006814 adopted and entered on October 4, 2019, which established an Extended TCJA Temporary Surcharge of -4.72% effective October 11, 2019.

Supplement No. 16 is filed in accordance with the Order at the above noted docket and sets the Extended TCJA Temporary Surcharge to zero for the period November 1, 2020 through December 31, 2020. On or before December 1, 2020, UGI Gas will file a reconciliation of the Extended TCJA Temporary Surcharge once UGI Gas is able to identify such actual reconciliation amount following the accounting close for the month of October. This reconciliation rate will be effective January 1, 2021 through October 10, 2021, at which point the rate will expire.

Given the warmer than normal weather experienced during the past year, UGI Gas is continuing to apply the current -4.72% rate through the period ending October 31, 2020. This continuation does not modify the timing of the ultimate reconciliation period which still requires awaiting October accounting close data.

RULES AND REGULATIONS

12. RIDER C - Continued

EXTENDED TCJA TEMPORARY SURCHARGE

The Extended TCJA Temporary Surcharge shall be a negative surcharge of -4.72% which will apply as a credit for intrastate service to all customer bills rendered on and after October 11, 2019. This negative surcharge will be distributed equally among the utility's various customer classes, exclusive of STAS and automatic adjustment clause revenues.

The Extended TCJA Temporary Surcharge shall expire October 31, 2020.

Following the expiration date of October 31, 2020, the Extended TCJA Temporary Surcharge shall be reconciled, with interest on the net over or under collection as of November 1, 2020 equivalent to one year (mid-point of return period to mid-point of reconciliation period) being applied at the residential mortgage lending rate specified by the Secretary of Banking in accordance with the Loan Interest and Protection Law (41 P.S. §§ 101, et seq.).

On and After November 1, 2020: Extended TCJA Temporary Surcharge
