Dear Secretary Chiavetta:

In their October 29, 2020 Recommended Decision (RD), Administrative Law Judges Mary D. Long and Emily I. DeVoe recommended that the Commission approve without modification the unanimous Joint Petition for Settlement filed on September 30, 2020. As noted in the RD, all the parties support the Joint Petition for Settlement and all the parties agreed to waive the filing of exceptions upon a recommendation of the RD that the Joint Petition for Settlement be approved without modification. As such, Pittsburgh Water and Sewer Authority (“PWSA”) will not be filing exceptions. Given this, PWSA respectfully requests that the Commission consider the RD at its December 17, 2020 public meeting. While the effective date of the proposed rate increase was voluntarily suspended until January 14, 2021, an earlier decision from the Commission would provide a reasonable period of time for PWSA to finalize the tariffs and notify customers of the final decision in advance of implementing any new rates on January 14, 2021.
