MOTION OF THE OFFICE OF CONSUMER ADVOCATE FOR AN EXTENSION OF TIME FOR COMMENTS

Pursuant to Sections 1.15 and 5.103 of the Pennsylvania Public Utility Commission's (Commission) regulations, 52 Pa. Code Sections 1.15, 5.103, the Office of Consumer Advocate (OCA) hereby files this Motion for an Extension of Time for Comments (Motion) in the abovecaptioned proceeding. Through this Motion, the OCA respectfully requests that the Commission extend the deadline for the filing of Comments for a period of thirty (30) days, from January 19, 2021 to February 18, 2021. In support of this Motion, the OCA provides the following:

- 1. On December 3, 2020, a Secretarial Letter was issued on behalf of the Commission seeking comments from utilities and other stakeholders on potential future regulatory policies related to the utilization of electric storage within electric utility distribution planning. The Secretarial Letter invited interested parties to submit written comments for the Commission's consideration within 30 days of publication in the Pennsylvania Bulletin. The Secretarial Letter was docketed at Docket No. M-2020-3022877.
- 2. On Saturday, December 19, 2020, the Secretarial Letter was published in the Pennsylvania Bulletin. Accordingly, the due date for Comments is Tuesday, January 19, 2021.
- 3. The OCA respectfully requests that the Commission extend the due date for Comments by an additional period of 30 days, from January 19, 2021, to Thursday, February 18, 2021.

- 4. Utilization of electric storage assets is an important issue that presents many complex and novel policy issues. As such, it is critical that the OCA and other interested parties be provided the necessary time to properly address this topic and provide the Commission a sufficient record for its consideration.
- 5. The current deadline of January 19, 2021, however, will make it difficult for the OCA to accomplish this goal and to address the complexity, depth, and number of issues raised by the Secretarial Letter. The existing deadline is also challenging to meet due to the timing of the holidays, as well as the other obligations and commitments of the OCA in other Commission proceedings.
- 6. The OCA has notified the Commission's Bureau of Investigation and Enforcement (I&E), the Office of Small Business Advocate (OSBA), the Energy Association of Pennsylvania (EAP), the Industrials, Natural Resources Defense Council (NRDC) and Earthjustice of this request. All have indicated support for a 30-day extension of time in this matter.

WHEREFORE, the Office of Consumer Advocate respectfully requests that the Commission extend the deadline for the filing of Comments by a period of thirty (30) days, from Tuesday, January 19, 2021, to Thursday, February 18, 2021. The OCA appreciates the Commission's consideration of this request.
