Pursuant to the Interim Order issued in the above-captioned proceeding on January 11, 2021, PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) hereby files this letter advising Deputy Chief Administrative Law Judge Mark A. Hoyer and Administrative Law Judge Emily I. DeVoe (collectively, “ALJs”) about the Company’s positions regarding: (1) the Joint Expedited Motion for Extension of Procedural Schedule (“Joint Expedited Motion”) and the procedural schedule it outlines; and (2) the Office of Administrative Law Judge’s (“OALJ”) Proposed Revised Schedule set forth in the Interim Order.

PPL Electric supports both the procedural schedule set forth in the Joint Expedited Motion and the Proposed Revised Schedule set forth in the Interim Order.

The Company has been actively discussing the adoption of a litigation schedule using the OALJ’s Proposed Revised Schedule with the other parties. PPL Electric supports extending the deadline for evidentiary hearings from February 8, 2021, to February 9, 2021, to accommodate the scheduling of hearings in other Phase IV Energy Efficiency and Conservation (“EE&C”) Plan proceedings. If the dates in the OALJ’s Proposed Revised Schedule are modified and adopted accordingly, PPL Electric supports the following litigation schedule:
