On January 11, 2021, Deputy Chief Administrative Law Judge ("DCALJ") Mark A Hoyer and Administrative Law Judge ("ALJ") Emily I. DeVoe issued an Interim Order in the above-referenced proceeding, offering an "OALJ Proposed Revised Schedule" and directing parties to respond to this proposal and to the Joint Expedited Motion for Extension of Procedural Schedule filed by certain parties ("Moving Parties") on January 8, 2021.
