NRDC Letter of Non-Opposition to Settlement, No Main Brief

Dear Judge Hoyer and Judge DeVoe,

The purpose of this letter is to notify Your Honors and the Commission that Natural Resources Defense Council (NRDC) does not oppose the Joint Petition for Settlement in this proceeding.

NRDC was actively involved in settlement negotiations in this proceeding, and is supportive of many of the provisions incorporated into the Joint Petition for Settlement agreed to by PECO Energy Company, the Office of Consumer Advocate, the Office of Small Business Advocate, the Coalition for Affordable Utility Services and Energy Efficiency in Pennsylvania, and the Philadelphia Area Industrial Energy Users Group. We note in particular the *Pilots to Incentivize Comprehensive Projects* (paragraphs 10-14), which is responsive to the Commission's findings in its Phase IV Implementation Order that "more comprehensive programs are beneficial to electric customers" and its encouragement to EDCs to "consider implementing a comprehensive mix of measures." While NRDC was ultimately unable to join the Settlement, we nevertheless stand in non-opposition thereto. NRDC's position of non-opposition to this Settlement is conditioned on the approval of the Commission to the terms and conditions contained therein, and we note that disruption to the delicate balance of the parties' many and varied interests in this proceeding may impact our position of non-opposition.
