Dear Secretary Chiavetta:

The purpose of this letter is to inform the Commission that PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) will not be filing a Revised Phase IV Energy Efficiency and Conservation Plan (“Phase IV EE&C Plan”) at this time.

Several aspects of the Company’s Phase IV EE&C Plan will be need to be changed depending on how the Pennsylvania Public Utility Commission (“Commission”) ultimately adjudicates: (1) the Joint Petition for Approval of Partial Settlement that was filed on February 26, 2021; and (2) the PP&L Industrial Customer Alliance’s (“PPLICA”) proposal to reduce the Commission-established peak demand reduction compliance target for PPL Electric. Any changes resulting from the Commission’s final ruling will be made in the Company’s compliance filing.
