Dear Secretary Chiavetta:

The purpose of this correspondence is to bring to the Pennsylvania Public utility Commission's ("Commission") attention the need for expedited resolution of the Petition of Just Energy Pennsylvania Corp for Reconsideration of Pennsylvania Public Utility Commission Staff Action ("Petition for Reconsideration"), filed at the above-captioned Docket on October 21, 2021. Just Energy Pennsylvania Corp ("JEPC") is an active Pennsylvania electric generation supplier ("EGS") whose financial security on file with the Commission is due for renewal on December 9, 2021. JEPC's Petition for Reconsideration seeks review of the Commission Staff's October 1, 2021 denial of JEPC's request for renewal of its reduced level of security.


The Commission Public Meeting schedule indicates that the Public Meetings currently scheduled prior to the expiration of JEPC's current approved security level will occur on November 18, 2021 and December 2, 2021. If Commission action on the Petition for Reconsideration does not occur until December 2, 2021, timely submission of the correct security amount to the Commission to ensure continuous security coverage of JEPC's operations could be jeopardized due to the lead time needed to obtain security instruments.

JEPC respectfully requests Commission action, by any lawful means, on its Petition for Reconsideration at least ten (10) days prior to its security renewal date of December 9, 2021 so that its required security amount has been established by Commission action in sufficient time to allow preparation and timely submission of the correct security instrument. Toward that end, JEPC notes that at this time, its Petition for Reconsideration is an uncontested request.


