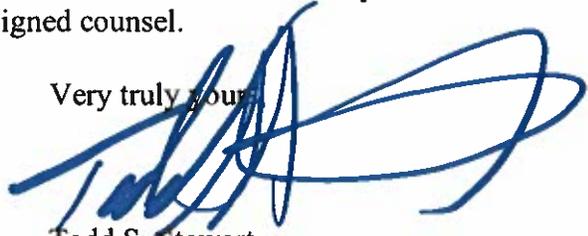
The purpose of this letter is to notify the Commission, pursuant to the requirements of 52 Pa. Code § 62.105, of a change to the information provided to the Commission in Dominion Energy Solutions' ("DES") predecessor's initial Application for a Natural Gas Supplier ("NGS") license, and any subsequent modifications. DES has changed its corporate form, from that of a corporation, with the designation "Inc." to a limited liability company, with the designation "LLC". Copies of the appropriate Department of State filings, evidencing the change, are attached hereto. Appendix A contains the documents from Delaware, DES' state of incorporation, while Appendix B contains the stamped Pennsylvania Department of State filing.

DES has been operating as an NGS since 1999 when the Commission approved its Application at the above-docket number. The initial application was filed under the corporate name of CNG Retail Services Corp. Dominion Energy Solutions began operating under the DES name on October 8, 2009, when it notified the Commission that it was adding "Dominion Energy Solutions" as a trade name. On July 19, 2017, DES notified the Commission that its corporate name, then Dominion Retail, Inc., had been changed to Dominion Energy Solutions, Inc. That filing included the appropriate documents from the Departments of State of Delaware, where DES is incorporated, and Pennsylvania.
