Re: Distribution System Improvement Charge - Implementation Order to address all issues pertaining to the distribution system improvement charge calculations required in the Pennsylvania Supreme Court's decision in McCloskey v. Pa. PUC, 255 A.3d 416 (Pa. 2021).

Dear Ms. Clark,

With this Secretarial Letter and for the reasons expressed below, the Pennsylvania Public Utility Commission (Commission) is granting the Energy Association of Pennsylvania's (EAP) Petition for an Extension of Time to File Comments in the above-referenced proceeding. Comments to the April 22, 2022 Secretarial Letter, are now due within 90 days of the issuance of that Secretarial Letter, or by July 22, 2022. The EAP states that it is acting on behalf of its electric distribution companies (EDCs)¹ and natural gas distribution companies (NGDCs)²

On April 22, 2022, the Commission issued a Secretarial Letter noting its previous affirmance of the material question posed by the FirstEnergy Companies to initiate a generic proceeding at Docket M-2012-2293611 for the purpose of revising the Distribution System Improvement Charge ("DSIC") Model Tariff adopted in the Commission's Implementation Order entered at that docket on August 2, 2012. The Commission seeks input on how to comply with Section 1301.1(a) of the Pennsylvania Public Utility Code as interpreted by the Pennsylvania Supreme Court in *McCloskey v*.

Pa. PUC, 255 A.3d 416 (Pa. 2021)³. Specifically, the Commission invited comment from interested parties on a list of bulleted issues and key topics prior to holding a working group meeting in order to provide a forum for discussion and feedback from stakeholders.

On May 11, 2022, the EAP filed a petition for an expedited order granting an extension of time to file comments to the Commission's secretarial letter regarding the issues pertaining to the DSIC calculations and Model Tariff required by the Supreme Court's decision. The EAP states that given the complex technical, legal, and policy issues raised by the Secretarial Letter, an extension of time until July 22, 2022 for all interested parties to file comments should be granted. In support of its extension request, the EAP believes that the extra time sought through this request will not impede the Commission's goal to address "all issues pertaining to the [DSIC] calculations required by the Pennsylvania Supreme Court" that will benefit all potential commentators and the Commission by eliciting a more thorough and nuanced analysis.

EAP states that it has contacted the Office of Consumer Advocate, the Office of Small Business Advocate and the PUC Bureau of Investigation & Enforcement (collectively, the Statutory Advocates) with each responding that there was no objection to EAP requesting a sixty (60) day extension of time.

The Commission recognizes the importance and complexity of the issues raised in this proceeding and that a thorough and complete record will better inform the Commission, the public utilities, and the Statutory Advocates on these important ratemaking issues. For these reasons, the Commission will grant the Petition for an Extension of Time to File Comments. Comments to the April 22, 2022 Secretarial Letter are now due within 90 days of the date of that letter, or by July 22, 2022.
