Dear Secretary Chiavetta:

Pursuant to the Commission-approved Settlement in this matter, SPLP was required to retain and independent expert to conduct a Remaining Life Study for the Mariner East 1 pipeline ("ME1"). The Remaining Life Study was submitted on July 8, 2021. The Settlement further provides: "For so long as ME1 remains in Highly Volatile Liquid ("HVL") service, SPLP agrees to supplement the Remaining Life Study by providing a summary report on an annual basis..." Settlement at 6.

SPLP hereby notifies the Commission that as of June 8, 2022, the ME1 pipeline is no longer in HVL service. Accordingly, consistent with the Settlement term recited above, SPLP will not be submitting an annual update to the Remaining Life Study.
