In response to the Pennsylvania Public Utility Commission’s April 22nd Secretarial Letter, Philadelphia Gas Works’ (“PGW”) has reviewed the Distribution System Improvement Charge (“DSIC”) Model Tariff in light of the Pennsylvania Supreme Court’s interpretation of Section 1301.1(a) of the Pennsylvania Public Utility Code, 66 Pa. C. S. § 1301.1(a), in *McCloskey v. Pa. PUC*, 255 A. 3d 416 (Pa. 2021) and determined that no changes are needed in the paragraphs of the DSIC Model Tariff which pertain to City Natural Gas Distribution Operations. Based on this review PGW is not proposing any changes to how the DSIC applies to City Natural Gas Distribution Operations such as PGW.
