Dear Secretary Chiavetta:

On behalf of the Office of Consumer Advocate, I am formally requesting an extension of the Reply Comment deadline in the captioned rulemaking. The regulations setting out the Use of the Fully Projected Future Test Year (FPFTY) were published in the Pennsylvania Bulletin on Saturday, October 1st. Per the Commission's order, Comments are due November 15, 2022 (45 days from October 1<sup>st</sup>) and Reply Comments are due December 30, 2022 (45 days from the date comments are due).

We anticipate being able to meet The Comment deadline, but we are requesting that the Commission extend the Reply Comment deadline to Tuesday, January 17, 2023. We anticipate that there will be a significant number of comments filed at the docket. Given when the order was published, the Reply Comment period currently coincides with the holiday season (both Thanksgiving and Christmas). We are concerned that there is insufficient time to fully review all comments and draft Reply Comments.
