Yes indeed, an hour ahead and 20 degrees above, I did look over the letter, it appears the Monona Farms is not a registered pipeline operator not did they report the pipeline assets, I searched under "Monona" and "Stickle" was unable to find anything, we had a similar situation in the past, but the entity buying the assets had registered with the PUC and reported the exact miles of the pipelines so it was no problem absolving the former operator since the assets were accounted for via the new operator registering them. That appears not to be the case here, do you know if the buyer is operating under a different name?
