Dear Secretary Chiavetta:

On December 30, 2022, PPL Electric Utilities Corporation ("PPL") filed a Petition to for Approval of Changes to its Act 129 Phase IV Energy Efficiency & Conservation Plan ("Petition") with the Pennsylvania Public Utility Commission ("PUC" or "Commission"). The PP&L Industrial Customer Alliance hereby files this Letter in Lieu of Comments to the Petition.

The Petition proposes both major and minor changes to PPL's Act 129 Plan. The major changes include several changes that collectively shift the program budget to reallocate investment from the Large Commercial & Industrial ("C&I") sector budgets to the Small C&I sector budgets. While the Petition does not address impacts on PPL's Phase IV Act 129 Compliance Rider ("ACR"), the proposed budget adjustments are anticipated to significantly impact the ACR charges for PPLICA members. Accordingly, PPLICA respectfully requests that the Commission take all reasonable steps to review the proposed budget reallocation within the requisite timeframe to ensure PPL reflects the adjusted sector budgets in the public filing of its June 1, 2023, ACR rate adjustment.
